UK GOVERNMENT - 1. Summary ...b. There are 2 definitions of a death in a person with COVID-19 in England, one broader measure and one measure reflecting current trends: 1) A death in a person with a laboratory-confirmed positive COVID-19 test and either died within 60 days of the first specimen date or died more than 60 days after the first specimen date, only if COVID-19 is mentioned on the death certificate
