Animal studies are critical for vaccine development. However, vaccines for Covid-19 have bypassed animal studies and gone straight to human trials. In the absence of animal studies, the outcomes in humans cannot be predicted.

It must also be noted that the manufacturers of Covid-19 vaccines could be given full protection from prosecution if they cause death, injury or any harmful side-effects to people who are injected with their vaccines.

The race is on to find a vaccine for the **Coronavirus (COVID-19).** But many of these vaccines are being developed using cell lines that were originally derived from tissue of babies killed by abortion in the 1970s and 80s.

Researchers from big pharmaceutical companies to small biotech companies and universities, have been pushing out dozens of vaccine candidates and have **fast-tracked** vaccine candidates to clinical trials in record time. The pharmaceutical companies are sprinting to have a vaccine

ready by the end of the year or by early 2021.

Several COVID-19 vaccine frontrunners, including those being developed by Moderna, Oxford University/AstraZeneca, CanSino Biologics/Beijing Institute of Biotechnology, and Inovio Pharmaceuticals, are using a human kidney cell line called HEK-293 to develop their trial vaccines. HEK-293 was originally derived from kidney tissue taken from a baby girl who was aborted in the Netherlands in 1972.

Additionally, *Janssen*, the pharmaceutical division of consumer product giant *Johnson & Johnson*, is using the human cell line **PER.C6** to develop its vaccine. The **PER.C6 cell line was derived from eye tissue taken from a baby boy who was aborted in the Netherlands in 1985.**

Will there be Forced Vaccinations?

There is a real danger that COVID-19 vaccines could become compulsory. The **'Coronavirus Act'** passed by the Westminster Parliament grants the Government *"emergency powers"* to handle COVID-19. The Act outlines the Government has *"reasonable"*, *"proportionate"* and *"necessary"* powers - each of which is likely to change over time and is subject to interpretation.

When questioned about mandatory vaccinations, the Government Health Secretary Matt Hancock did not rule out the option that **vaccines would be compulsory.**

What can I do?

Forced vaccinations for COVID-19 would be an infringement of your civil & religious liberties and human rights.

Contact your MP or Assembly Members (MLAs) by logging on to **www.theyworkforyou.com** and tell them you are totally opposed to mandatory vaccinations, and that mandatory vaccinations must not be enforced on the people of Northern Ireland.
